KOVA Limited Warranty

Product Categories: Mirrors.

KOVA Products, Inc. warrants that the product categories listed above will be free of defects in material and workmanship when properly installed and serviced during normal residential or light commercial installation applications per the table below. Unless specifically stated otherwise, the warranty start date begins on the date of delivery.

Subject to the terms and conditions listed below, KOVA Products, Inc. will repair, provide a replacement part or product, or refund the original purchase price for defective products during the warranty period. The decision to resolve warranty defects by repair, replacement, or refund will be made at KOVA Products, Inc.'s sole discretion. KOVA Products, Inc. recommends using a licensed professional for all installations or repairs.

THIS IS A LIMITED WARRANTY. THE FOLLOWING CONDITIONS ARE NOT COVERED BY THE WARRANTY:

- Faults or damage, including breakage, caused by installation⁴ error, improper maintenance, neglect, altering, tampering, or careless operation or handling of the products that are not in accordance with KOVA Products, Inc. instructions or specifications, or if it is used for other than the intended purpose after the product has been delivered and accepted by the receiving party – whether performed by a contractor, service company, or yourself – are excluded from this warranty.
- 2. Damage caused by the use of cleaners not in compliance with cleaning recommendations.
 - a. Avoid abrasive cleaners, steel wools, and harsh chemicals as these will scratch, damage, and/or dull the product and/or finish and will void this warranty.
- 3. Normal wear and tear due to the normal aging of the product, including parts that are expected to deteriorate over time. Gloss reduction, scratching, abrasions, deterioration (due to the use of paints, solvents, or other chemicals), staining or alkaline etching of the finish over time due to use, cleaning practices, or water or atmospheric conditions, are not manufacturing defects but are indicative of normal wear and tear.
 - a. This warranty does not cover temporary marks on the products including but not limited to metal marks, fingerprints or smudges or other temporary marks made by household items.
- 4. All KOVA Products, Inc. mirrors are manufactured under the standards and quality specifications in ASTM standards C1036, ASTM C1503, ASTM B117, and ASTM D1654. Ongoing

support, normal wear and tear, black edging, de-silvering, or slight scratching are not covered by this warranty.

- 5. Damage caused by direct exposure to water or other liquids.
- 6. This warranty does not cover products that the customer decides they do not like after installation due to color, styles, or other opinions based on personal preference.
- 7. This warranty does not cover cosmetic damage not reported in the first 48 hours after delivery. All products must be inspected prior to installation. Installation of products with visual defects or nonconformities apparent prior to installation voids this warranty.
- Discoloration, rust, or oxidation resulting from caustic or corrosive environments including but not limited to high salt concentrations, high moisture, humidity, or exposure to chemicals. Installation applications within 5 miles (8 kilometers) of a body of saltwater are considered high salt concentration environments.
- 9. Damage caused after delivery, including damages to the finish of appliance or home incurred during installation, including but not limited to floors, cabinets, countertops, walls, etc.
- 10. Damage from children, pets, or insects.
- 11. KOVA Products, Inc. is not responsible for damage or injury caused in whole or in part by natural calamities or acts of God, (including but not limited to earthquakes, tornadoes, tropical storms, hurricanes, lightning, windstorm, fires, floods), exposure to corrosive contaminants, (including but not limited to salt water or chemicals in storm waters), explosions, biological infestations, improper storage or handling, job site conditions, architectural and engineering design, structural settling or movement, acts of vandalism, or accidents.
- 12. Outdoor installation: Unless specifically stated otherwise, this product is not recommended for outdoor installations, installation in indoor swimming pools, shower pans, grill tops, hot tubs, saunas, steam rooms, recreational vehicles, air- or water-going vessels.
- 13. Labor: This warranty is for material only. Katerra is not responsible for labor charges including installation, removal, and reinstallation; or other incidental or consequential costs associated with surrounding material such as doors, frames, sills, countertops, walls, ceilings, paint, cabinets, or flooring.
- 14. Light Commercial Use: Unless specifically stated otherwise, this limited warranty is extended to light commercial applications including multi-family apartment units, schools, professional office buildings, retail, hospitality guest rooms, and other similar installation applications only. Excluded from this limited warranty are operating environments and usage scenarios that significantly differ from normal residential usages patterns and operating conditions. Examples include industrial/manufacturing workspaces where employees are regularly required to wear personal protective equipment (hard hats, safety glasses, protective coveralls, etc.), professional kitchens & restaurants, food service, laundromats, hospitals, laboratories, and other high-volume, heavy-use, harsh or chemically caustic environments. 15. If stored before installation, mirrors must be kept in a dry indoor environment between 45 and 85 degrees Fahrenheit or the warranty is void.

The cost of repair or replacement under the above excluded circumstances shall be borne by the customer. Under no circumstance shall the liability of KOVA Products, Inc. exceed the original purchase price of the warranted product(s).

Repaired parts or replacement units are warranted for the remaining portion of the original unit's warranty period. The original warranty period is not extended by repair or replacement activities.

This limited warranty is non-transferable and only applies to the original owner and the original installation location in the United States. Proof of purchase is required for any warranty claim.

Please follow KOVA Products, Inc. maintenance guidelines below when caring for your mirrors.

GLASS AND MIRROR CARE

- The best and safest cleaner for glass and mirror is clean, warm water used with a soft clean cloth. Be sure to not allow edges of the mirror to remain wet for extended periods.
- Do not use any acidic or alkali cleaners on glass, mirror, or installation metals.
- Never use abrasive cleaners or powders.
- Never use abrasive cleaning instruments like steel wool.
- For more aggressive cleaning, use commercial glass cleaners that contain no ammonia or vinegar.
- Avoid newspaper or any other towels that contain contaminants or lint
- Avoid spraying cleaners directly on glass or mirrors. We recommend spraying onto soft cloth or towel and then cleaning surface.
- Always use a soft, clean, grit-free cloth when cleaning to reduce chances of scratching and abrasions.
- Be sure to dry product fully to avoid prolonged contact with cleaners and solvents. Keep cleaners off mirror backing to avoid deterioration.
- Good ventilation of glass or mirror product avoids moisture buildup ("sweating") and reduces risk of corrosion or damage to glass and mirror. This includes proper bathroom ventilation and utilizing buttons/spacers on tabletops.
